Getting Started as a CCP Student

(Preferred Tri-C deadline: May 15)

- Intent to Participate form due by May 1 to high school counselor (required by the state)
- Complete online Tri-C CCP application
- Submit transcript or qualifying ACT/SAT test scores to determine eligibility
 - Depending on GPA and grade level, Tri-C placement test may be required





CCP Registration Process

- Receive decision letter and registration instructions via email
- Meet with school guidance counselor to discuss courses you will take
- Submit Tri-C's authorization to attend form
- Meet with Tri-C Counselor to choose courses that will fulfill degree requirements
- Register for courses
- Attend a College Credit Plus Orientation

Admission Requirements

Preferred requirements for all applicants:

- 3.00 cumulative GPA (required by the state)
- ACT or SAT scores are optional for 2021-22
- Applicants who do not take the ACT or SAT will be required to complete placement testing through the University.



How to Apply

- Complete the Online Undergraduate Application
- Submit official high school transcripts
- Print and Submit the CCP Signature Page which requires a student, parent & counselor signature
- Submit ACT or SAT scores (optional)
- The application deadline for the summer and fall semesters is April 15
- The spring semester deadline is October 15

Students applying to enroll at the Akron Campus or in distance learning classes must apply to the Akron Campus.

Students applying to enroll at Wayne College or UA Medina must apply to the Wayne campus.

College Credit Plus Updates for 2021-2022



- Returning applicants will no longer need to reapply to participate in CCP
- New Student Application Deadlines 2021-2022
 - Summer 2021 April 15
 - Fall 2021 June 1
 - Spring 2022 October 15
- CCP Eligibility
 - Student must have one of the following:
 - Qualifying ACT, SAT, or Accuplacer score
 - (or) an unweighted GPA of 3.0 or higher

WHAT IS COLLEGE CREDIT PLUS?

- For College-Ready Students in Grades 7-12
- · Students can earn college credits for free
- Courses count as both High School and College Credit
- Cost of CCP shared by school districts, colleges/universities and state taxpayers
- Students/parents pay for parking and provide transportation
- Student Choice Driven

WHAT IS COLLEGE READY?

STATEWIDE ELIGIBILITY CRITERIA

INSTITUTION OF HIGHER EDUCATION ADMISSIONS CRITERIA

COURSE PLACEMENT CRITERIA

- College-Ready Assessment Scores in at least one subject area
- Assessment scores below college-ready, but within one standard-error of measurement and has a 3.0+ GPA or receives recommendation
- Due to COVID-19 for 2021-2022, a student can be considered eligible with a 3.0 GPA in absence of test scores.

- Selective Institutional Criteria
- Open Enrollment

- College-readiness scores relevant to course/program requirements
- Other program-specific pre-requisites

- Expands school curriculum

CCP & HIGH SCHOOL REQUIREMENTS

HIGH SCHOOL REQUIREMENTS

- Graduation Requirements cannot be waived
- CCP courses can fulfill some of the high school assessment requirements
- Students are still responsible for some high school assessments



HOW ARE GRADES POSTED?

College/University provides final grades to HS

 High School posts the course title, grade, and institution on transcript

• Grades earned in college courses are included in GPA/Rank

Weighting of grades



ATHLETIC ELIGIBILITY

- CCP Students can participate in HS athletics
- Follow OHSAA guidelines
- Summer CCP courses can't be used for eligibility
- · Verification of college midterm grades may be required









TEXTBOOKS

- Costs are paid by the school district
- Each district has their own policies regarding how students purchase textbooks
- Recommend not opening a sealed textbook
 or computer disk package until the student is certain
 they will remain in the course





HOW CAN STUDENTS PARTICIPATE?

CCP REQUIREMENTS FOR PARENTS/STUDENTS AT PUBLIC SCHOOLS

- Attend an information session
- Sign document verifying counseling received
- Complete and submit Letter of Intent by May 1 for 2021-2022 school year
- Apply for CCP at college(s) of choice by their deadlines
- Non-public and homeschooled students follow guidelines to apply for funding through the State



ENROLLMENT OPTIONS

• Summer Semester

• Fall Semester

• Spring Semester





CCP GUIDELINES

- Limit of 30 college credits per year
- Limit of 120 credits maximum, even if beginning CCP in 7th grade
- Cannot attend beyond Spring Semester of your senior year in high school
- Verify course choices and changes with your school guidance counselor

COURSE ELIGIBILITY RULE

Courses Eligible for Funding

- Level I Courses first 15 credit hours
 - Transferable courses: Part of CTAG, OTM, or TAG or equivalent https://www.ohiohighered.org/transfer
 - Courses in Computer Science, Information Technology, Anatomy, Physiology, or Foreign Language (including ASL)
 - Technical certificate course
 - 15-credit hour or 30-credit hour model pathway course
 - Study skills, academic or career success skills course
 - Internship course
 - Other course(s) approved by the Chancellor by March 1 annually
- Level II Courses anything that is not a Level I course

NON-ALLOWABLE COURSES

Courses Not Allowable or Eligible for Funding

- One-on-one private instruction courses
- Courses with fees that exceed amount set by the Chancellor
- Study Abroad courses
- Physical Education courses
- P/F or S/U graded courses (unless course is an internship or transferable course)

 *Only allowable for 2021-2022 AY due to COVID-19 and must follow University guidelines
- Remedial or Sectarian religion course

UNDERPERFORMING STUDENT RULE

Underperforming Participants

- · Impact on future college enrollment
- · Impact on college financial aid

CCP Probation

- Student earns less than a cumulative 2.0 in college courses OR withdraws from two or more courses in the same term
- . When on probation, may enroll in no more than 1 college course
- · Cannot take courses in the same subject where a D, F or no credit was earned

CCP Dismissal

- After being on CCP Probation for 2 consecutive college terms
- Cannot enroll in college courses for the following college term
- After one term on dismissal, can reapply to take CCP courses through your school district (students can appeal their CCP dismissal status within 5 days of being notified of the dismissal)

CCP COURSES SUMMARIZED

- CCP courses taken must follow State policies
- Courses must be taken for college credit and apply toward a degree or workforce certification
- Research and choose classes to fit career pathways
- Know how the course(s) you take will apply to your intended college degree
- Random Courses do not equal a Degree
- Students must meet course prerequisites
- Registration occurs during open registration after on campus students have registered



WHAT'S NEXT? HOW DO I PARTICIPATE? HOW DOES CCP WORK?

APPLICATION PROCESS & ORIENTATION REQUIRED MATERIALS MAY DIFFER BY INSTITUTION

- Meet state remediation free standards
- CCP Application (only new applicants)
 - Returners will fill out CCP Continuation Form via their KSU email
- SAT/ACT scores or Accuplacer scores are an optional credential. As an applicant, you can decide if you want to submit as part of your application.
- Official HS transcripts
- Recommended 3.0 + GPA
- CCP Permission Form
 - Signed by student and parent

- Summer 2021 April 15
- Fall 2021 June 1
- Spring 2022 Oct 15

Attend Mandatory Orientation

 Regardless of location of class all new students must complete both the online orientation AND the on-campus orientation. Returning CCP students must schedule an advising appointment.

IN SUMMARY...

- Complete and submit the Letter of Intent no later than May 1 for 2021-2022 school year
- Apply or reapply for CCP to college(s)/university(ies) by application deadline
 - Provide all transcripts, required test scores, and permission forms
- Let colleges/universities know if you move or your information changes
- Know the deadline dates for each college/university
 - Application deadlines including ACT/SAT/Accuplacer test deadlines
 - Orientation Program dates
 - Course registration and withdrawal deadlines
- Let colleges know if you have an emergency that impacts your participation in CCP
- Remember that the college records belong to YOU, the student
 - For your parents to have any access, you need to provide a FERPA release
 - The courses you take under CCP start your permanent college transcript
 - · You, the student, are the only person who can request your college transcripts

AFTER CCP...

RISING SENIORS AND APPLYING TO COLLEGES

- Early Application/Decision
 - While participating in CCP, don't forget to apply to college for after high school graduation
 - Applications are usually available early during your senior year (as early as August 1)
 - · Application fee
 - · Apply as a New Freshman (not as a transfer student)
 - Consider retaking your ACT/SAT
- Important FAFSA Information for students who have completed CCP coursework
 - Apply as a New Freshman but indicate the number of credit hours you will have completed
 - Impact on students earning an Associates Degree or attending a summer class after HS graduation at another institution
 - Impact of CCP on financial aid eligibility
- How to request college transcripts
- Remember to check Transferability vs. Applicability

College Credit Steps to Take

This information is for those students interested in pursuing participation in the College Credit Plus program for the 2021-2022 school year. Below is a list of the next steps you should take in the application process for the program. Students/parents are responsible for the entire application process; the school does not initiate this process for you.

- Begin to identify institutions you are interested in applying to (previous students have attended Cleveland State University, Cuyahoga Community College, Kent State University or the Kent State University Twinsburg campus and the University of Akron--these are just examples for you).
- Locate the college's College Credit Plus application (some are the same as the undergraduate application and typically online at the college's website under Admissions) and selection criteria.
- Know the college deadline and submit your application to the college before the application deadline (this will differ by college).
- Submit the Letter of Intent, Student/Parent Acknowledgement and Transcript Request forms (included in this packet), to the High School Counseling Office no later than April 30, 2021.
- 5) Register for the ACT or SAT exam. The earlier you complete this exam the better. You can register at <u>www.actstudent.org/registf</u> or <u>www.sat.collegeboard.org/register</u>. Registration deadlines and test dates can be found on each website.
- Meet with your child's school counselor if you have any questions or reservations about participating in the program to gain additional insight.

You must **always** keep your school counselor informed of any changes to your College Credit Plus plan and details. It is <u>your</u> responsibility to make sure the school counselor has details of these changes, the college will not communicate these to the high school:

- courses added to your schedule
- courses dropped
- grades (student should print copy and bring to counselor as soon as they are reported even though college will send official transcript after semester ends)

Remember: Additions, withdrawals or failures in CCP classes may have academic and financial implications and may also impact high school graduation.

Advanced Placement (AP) at NHS

- AP® courses are college-level courses offered in high school that help students acquire the skills and habits needed to be successful in college.
- Application/Enrollment Process: receive recommendations from current teachers, check AP Potential results from PSAT in your College Board account. Submit AP course requests during scheduling.
- All students enrolled in an AP course are required to take an the AP exam in May. Current cost is approximately \$94 per exam.
- A score of 3 or higher on an AP exam can typically earn students college credit and/or placement into advanced courses in college.
