What is the 20-mill floor?

Ohio law specifies that the application of the tax reduction factors cannot cause a school district's effective current expense millage rate (inside and outside combined) to fall below 20 mills.

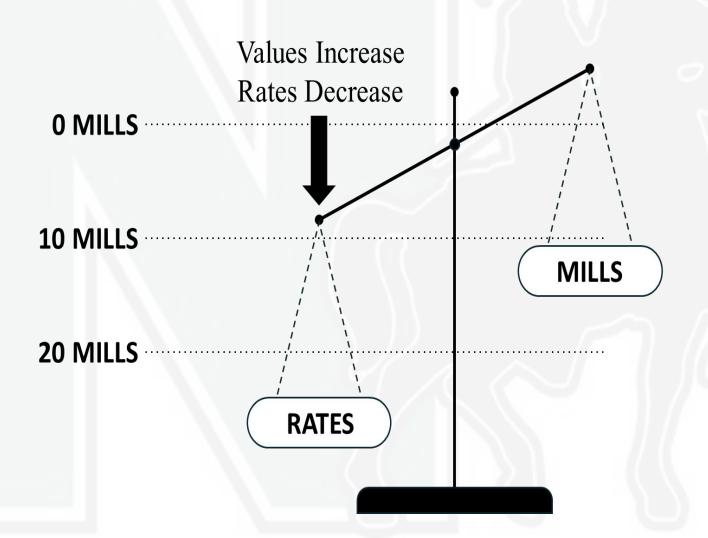

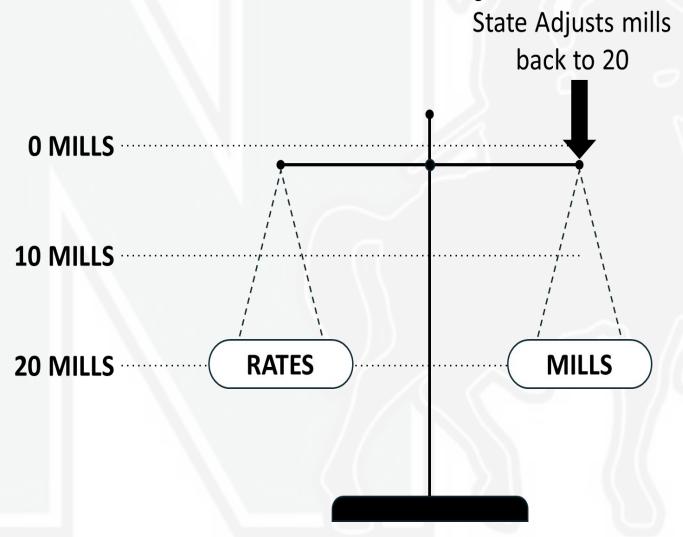

The 20-Mill Floor - Reappraisal



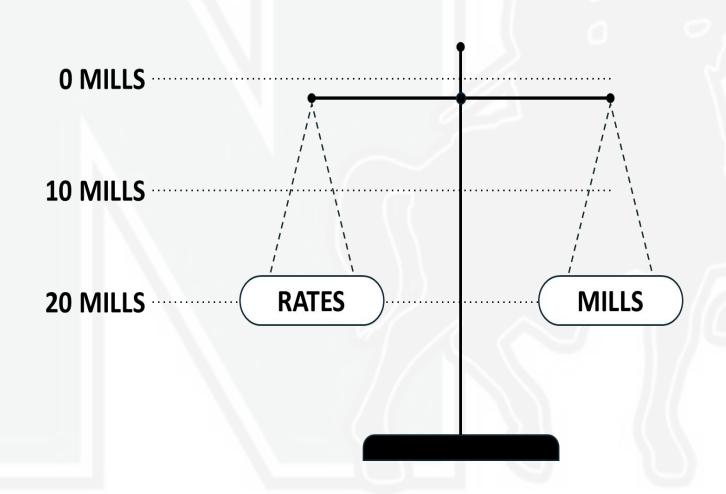
