- 4. Whether similar or equivalent service is provided to other pupils eligible for transportation
- 5. Whether and to what extent the additional service unavoidably disrupts current transportation schedules
- 6. Whether other reimbursable types of transportation are available; and

WHEREAS the option of offering payment in lieu of transportation is provided in Revised Code;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Education of the Nordonia Hills City School District, County of Summit, State of Ohio, that:

Section 1. This Board hereby approves the declaration of impractical to transport for the identified students, and offering them payment in lieu of transportation.

Section 2. # CLASS RANK

The Board of Education acknowledges the usefulness of a system of computing grade point averages and class ranking for high school students, both to inform students of their relative academic placement among their peers and to provide students, prospective employers, and institutions of higher learning with a predictive device so that each student is more likely to be placed in an environment conducive to success.

The Board authorizes a system of class ranking, by grade point average, for students in grades 9-12.

The Superintendent shall develop procedures for the computation of grade point averages and the assignment of class rank to implement this policy, which shall include:

- A. a provision for students completing graduation requirements before their class;
- B. a system for fairly averaging makeup courses;
- C. a statement of the methods for such computation and assignment to be made available for those to whom a student's grade point average or rank in class is released;
- D. recognition of the heavier burden of certain work, classes, courses, etc.

\* Beginning with the Class of 2026, students will be recognized using the following guidelines:

- A. Summa Cum Laude = 4.25 and above
- **B.** Magna Cum Laude = 4.0 and less than 4.25
- C. Cum Laude = Above 3.75 and less than 4.0

The Superintendent shall develop procedures for the computation of grade point averages and the assignment of graduation honors to implement this policy.

Class rank will not be publicized on student transcripts or report cards but is available upon request.

# SERVICE AGREEMENT

This SERVICE AGREEMENT (the "Agreement") is entered into on \_\_\_\_\_\_2022, between Nordonia Hills City Schools (the "District"), an Ohio Public School, charted under Chapter 3311 of the Ohio Revised Code, and Education Alternatives ("EA"), an Ohio nonprofit corporation, with offices at 5445 Smith Road, Cleveland, OH 44142 (the "Parties").

# BACKGROUND

WHEREAS, the District must provide a free and appropriate education ("FAPE") for its students, in accordance with state and federal laws;

WHEREAS, EA is a service provider equipped to educate students with varying educational, emotional and physical needs and meet the students' FAPE requirements;

WHEREAS, this Agreement permits the District to place individual students in designated EA programs, on an as needed basis during the 2022-2023 school year;

The Parties agree as follows:

# 1. EA Programming.

- A. The District has the choice of five programs, depending upon the individual student's needs and the student's Individualized Education Program ("IEP") team determination.
  - i. <u>Day Treatment Program</u>. EA's Day Treatment program is a non-residential program where students are provided mental health services in conjunction with the student's educational programming. EA's program features a 1:6 staff to student ratio, an emphasis on social skills development and behavior management. This program is best suited for students on an IEP, whose emotional issues prevent him or her from learning in a traditional education environment.
  - ii. <u>ECHO Program</u>. EA's "ECHO" program is a flexible computer and individual tutoring based learning model for students at risk of dropping out of school, in need of credit recovery, or wanting a non-traditional learning environment. ECHO primarily serves students in grades 9-12, but can accommodate middle school students. The ECHO program is not suitable for students who demonstrate significant emotional disturbance.
  - iii. <u>Coral Autism Program</u>. EA's "Coral Autism Program" is a program for students with an autism designation who may also have behavioral difficulties, but cannot function in a day-treatment classroom. The Coral program has a 1:3 staff-to-student ratio and the environment is tailored to the students' particular needs.
  - iv. <u>VisionQuest.</u> EA's "VisionQuest" program is for 18-22 year-olds with developmental disabilities, who require assistance in community involvement, employment and independent living skills.

- B. Due to the Covid-19 pandemic health crisis, EA may provide the above educational services remotely, through a variety of distance/online learning platforms. The District will be notified if an enrolled student is receiving services remotely, and the expected duration the educational services will be provided remotely. The per diem rates specified in Schedule A will apply whether the contracted services are provided on-site or remotely.
- 2. **Related Services.** The District is responsible for ensuring its students are provided related services designated by the student's IEP, including speech pathology, occupational therapy, and physical therapy services. EA will assist the District in providing these services, by permitting District personnel, and/or District independent contractors, to provide these services at EA facilities. The District shall be solely responsible for contacting and contracting with the licensed professionals who will provide these services to the District's students.
- 3. Term. The term of this Agreement shall begin July 1st, 2022 and will automatically expire June 30th, 2023.

# 4. Rates and Billing.

- A. The District shall pay EA the per diem rate, shown in Schedule A attached to this Agreement, for each student enrolled by the District, not to exceed 182 educational school days. The educational school year includes all: teacher in-services, calamity days, truancy days, absenteeism, local and national catastrophes and parent teacher conferences, which may occur during the Term of this Agreement.
- B. The District shall pay EA the cost of providing the enrolled Day Treatment student's mental health services, if the student does not qualify for Ohio Medicaid behavioral health services. The per diem rates for such services are shown in Schedule A. If the student does qualify for Ohio Medicaid, then EA will bill the District for the lessor amount shown in Schedule A.
- C. Students are counted on the District's Average Daily Membership ("ADM") for federal, state and local funding purposes.

# 5. Termination Of A Student's Placement.

- A. <u>District's Obligations Cease</u>. In the event that the District is no longer legally or financially obligated to provide educational services to a particular student, or if the student is discharged from EA for any reason, the parties' respective obligations under this Agreement for that particular student shall terminate.
- B. <u>FAPE</u>. If the IEP team, in accordance with federal and state law, determines that a particular student is not benefiting from the EA's programming and services, the parties will terminate the student's placement at EA.
- C. <u>Student A Danger to Self or Others</u>. In the event that a EA mental health professional identifies a student to be homicidal, or have a strong likelihood of inflicting bodily harm on himself/herself or others that is not likely to be mitigated by EA's therapeutic approach, then the Parties will provide a more appropriate educational placement or immediately terminate the student's placement at EA. A more appropriate placement may be in-home instruction provided by EA staff, as determined by the IEP team and the student's needs.



# 6. Education Records.

- A. EA and the District agree to exchange all educational records pertaining to students placed under this agreement, including but not limited to: multifactored evaluations, re-evaluations, individual education program documents, functional behavior assessments, behavior intervention plans, report cards, progress reports, transcripts, assessments, discipline records and any other educational records necessary for the Parties to fulfill their respective educational and legal obligations.
- B. The District shall have access to its assigned students' educational records, and may request such records at any time. EA shall provide such records within fourteen (14) calendar days of the request.
- C. Before placement at EA has begun, the District shall provide to EA documents or information regarding a student's violent or aggressive propensities.

# 7. Background Checks And Teacher Licenses.

- A. EA represents and warrants that it has obtained criminal background checks for all EA employees having direct or indirect access to students, in accordance with Ohio Revised Code Sections 3319.39 and 3319.392.
- B. EA represents and warrants that its teachers hold current licenses in the state of Ohio.
- 8. **Insurance.** EA shall at all times during the Term, or any extension thereof, procure, maintain and keep in force general public liability insurance for claims for personal injury, death, or property damage, occurring in connection with EA, with limits of not less than Two Million Dollars (\$2,000,000.00) in respect to: death or injury of a single person or in respect to any one accident, and not less than One Million Dollars (\$1,000,000.00) per accident in respect to property damage.
- 9. Indemnification. EA, for itself and its agents, contractors, directors, employees, officers, representatives, successors and assigns hereby agrees to defend, indemnify, and hold harmless the District and its administrators, agents, attorneys, consultants, contractors, directors, employees, officers, owners, representatives, successors, assigns, and insurers from and against all liability, claims, causes of action, lawsuits, administrative proceedings of every name or nature, damages, loss, cost or expense, including attorney fees and other litigation costs, arising out of or in connection with: i) a breach of this Agreement by EA; or ii) any third party claims made by students, parents, or guardians arising out of the Day Treatment Services or use of EA facilities as provided for under this Agreement. Notwithstanding anything contained herein to the contrary, EA is not obligated to defend, indemnify, or hold harmless the District against: i) any claim (whether direct or indirect) if such claim or corresponding losses arise out of or result from, in whole or in part, the District's breach of its obligations set forth in this Agreement; or ii) a breach of the District's obligations pursuant to 20 U.S. Code §§ 1411-1419, or corresponding state special education law.

# 10. Miscellaneous.

A. <u>Merger.</u> This Agreement contains the entire understanding of the parties concerning the matters contained herein, and supersedes and replaces any prior or contemporaneous oral or written contractors or communications concerning the matters contained herein.



- B. Assignment. EA shall not assign this Agreement without the written consent of the District.
- C. <u>Notices.</u> All notices or communications under this Agreement shall be in writing and delivered by US mail or email to a designated EA email address.
- D. Amendments. All amendments to this Agreement shall be in writing and executed by both Parties.
- E. <u>Independent Contractor</u>. The Parties to this Agreement are independent contractors. There is no relationship of partnership, joint venture, employment, franchise or agency created by or between the Parties. Neither party has the power to bind the other, or incur obligations on the other party's behalf.
- F. <u>Captions and Headings</u>. The captions and headings throughout this Agreement are for convenience and reference only, and the words contained therein shall in no way be held to explain, modify, amplify or aid in the interpretation, construction or meaning of the provisions of this instrument.
- G. <u>Severability of Provisions</u>. Any provision of this Agreement which is prohibited or unenforceable shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining provisions of this Agreement.
- H. <u>Binding Effect.</u> This Agreement will extend to, benefit, and be binding upon the parties hereto and their respective heirs, beneficiaries, successors, and assigns.
- I. <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which will be deemed an original for all purposes and which together will constitute one and the same instrument. The parties agree that any duplicate of this Agreement, including electronic copies or photocopies, shall be deemed as sufficient evidence of the original Agreement.
- J. <u>Choice of Law.</u> This Agreement shall be governed and construed by the laws of the State of Ohio without regard to conflict of law principles.

This agreement for the provision of IP Telephony service ("Agreement") is entered between the Northeast Ohio Network for Educational Technology (a program of the Metropolitan Regional Service Council) (Provider") and Nordonia Hills City Schools ("Customer"), as verified by the signatures on the signature page below.

WHEREAS, Provider is an Information Technology Center ("ITC") organized as a Regional Council of Governments and operating as part of the Ohio Education Computer Network ("OECN"), which has been established by the State of Ohio to provide communications and other technology services to public schools and other authorized user entities; and

WHEREAS, the Customer is an eligible educational entity in the State of Ohio, and;

WHEREAS, the Provider through its technology center desires to provide to Customer and Customer desires to secure from Providers the Services detailed in this Agreement;

NOW, THEREFORE, in consideration of the premises and mutual promises and covenants contained herein, and for other good and valuable considerable, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby agree as follows:

### I. DEFINITIONS:

As used in this Agreement the following terms shall be defined as follows:

"Parties" shall mean the Customer and Provider collectively.

"Services" shall mean all of the duties and ministrations listed in Article III Performance of this Agreement and included on Schedule 1.

"User" shall mean a school or person authorized by a Customer to make use of the data services or equipment secured by Customer from Provider by this Agreement.

#### II. TERM AND TERMINATION

- A. This Agreement is effective for all services covered herein for the period of 07/01/2022 through 06/30/2025.
- B. Services provided through this Agreement will end 06/30/2025
- C. Upon a termination of the Agreement by the Customer prior to the end of the stated term, the Customer agrees to pay Provider for contractual obligations incurred by the Provider on behalf of Customer for the original three (3) year contract period.
- D. Provider reserves the right to discontinue Customer's access to the Provider's Service, terminate this Agreement and/or seek other legal or equitable relief for use of the Service that Provider deems to be in violation of the rules and regulations of the Ohio

State Board of Education or any other state or federal agency; or in violation of this Agreement; or local, state or federal, or international law; or are uncivil. For purposes of this Agreement, uncivil conduct includes, but is not limited to: 1) transmitting offensive or harassing statements; 2) developing and/or transmitting offensive or unlawful graphics; 3) transmitting sexual or ethnic slurs explicitly or as part of a joke; 4) soliciting or encouraging others to engage in sexual, offensive or unlawful acts; or 5) permitting or encouraging unauthorized access to the Provider's network and public networks including unauthorized access to the Internet.

### III. SERVICE PERFORMANCE

- A. Provider shall furnish Customer IP Telephony services on a 24-hour-per-day, 7 day-perweek basis, and as further described in attached Exhibit A.
- B. Provider shall be responsible for the maintenance of the Service and any Provider-owned service equipment located on Customer premises ("Service Equipment"). Provider and its agents shall have the right at any time during normal business hours and with advanced notice to enter the Customer's premises (complying with the Customer's visitors policy) for the purpose of maintaining, inspecting, and testing the Service Equipment. Provider shall have the right to charge the Customer costs and expenses incurred in identifying and correcting any failure in Customer's facilities or equipment, or in repairing or replacing Provider's Service Equipment which has been damaged or rendered inoperable by reason of the Customer's actions or omissions, or the failure or inadequacy of Customer's equipment.

### IV. CHARGES AND PAYMENT

- A. The price of this service for each of three (3) periods shall be the annual contract price for the service as prescribed in Schedule 1-a.
- B. Customer agrees to be solely responsible to Provider for all charges set forth on Schedule 1-a for the duration of the Agreement, regardless of the approval, denial and/or receipt of Erate funding.
- C Charges for the Services provided under this Agreement will be billed to Customer on an annual basis.
- D. Payment of all invoices sent shall be due within thirty (30) days of the invoice date.
- E. Late payments shall be subject to a service charge of one and one half percent (1 1/2%) of any and all unpaid balance unless expressly waived by the Provider in writing. Provider may at its sole discretion terminate or suspend the Services to any Customer whose payments are in arrears by more than sixty (60) days. Such suspension shall not be deemed a waiver of other legal or equitable rights the Provider may have for full payment. If the Customer's Service is suspended, Provider may charge a reconnection fee to cover the administrative cost of reconnection. The reconnection charge shall be in addition to amounts due for unpaid balances and/or the above described service charges.

### V. FORCE MAJEURE

Provider shall not be liable for any damages incurred as a result of the errors, omissions or negligence of Customer, its personnel, employees, agents or users. Provider shall not be liable for failure to perform if such failure is caused by acts of God, winds, fires, landslide, floods, droughts, famines, acts of public enemies, insurrection, military action, sabotage,

riots, or civil disturbances, failure of a utility or utility type service which is essential to the Provider's Service or other event(s) not reasonably within the control of the Provider.

### VI. WARRANTIES AND LIMITATIONS ON LIABILITY

- A. The following defines Provider's entire liability with respect to claims arising in any way out of the provision of or failure to provide the Service set out in this Agreement; with respect to any breach of its contractual obligations arising under the Agreement; with respect to any errors, omissions, or negligence of Customer, its personnel, employees, agents or users; and any representations, statements, or tortuous act or omission including negligence or gross negligence arising under or in connection with this Agreement (including any liability for the acts or omissions of its employees, agents, and subcontractors; subsequently referred to as the "Event of Default"). Provider shall not be liable, in respect of or arising out of an Event of Default or the performance, non-performance, or breach of its obligations under this Agreement, for any indirect, incidental, special or consequential damages (including as a result of loss of data or misinformation), including loss of profits, goodwill, revenue, data, or use, incurred by Customer or by any third party whether in an action in contract or tort, even if such damages were foreseeable or Provider had been advised of the possibility of such damages. Provider, from time to time, will be requested to provide consultation related to Service described within this Agreement. Provider will use reasonable efforts in this regard. Customer acknowledges and agrees that the limitation of liability shall apply to such consultation. Without derogating from the other provisions of this section and this Agreement, Provider's liability for damages for breach of this Agreement shall in no event exceed the amounts received by Provider under this Agreement.
- B. Customer warrants and represents that it will only utilize the Services provided for educational and educational administrative related activities on its premises.
- C. Provider reserves the right to discontinue Customer's access to the Provider's network and/or seek other legal or equitable relief for use of the Services that Provider deems to be in violation of the rules and regulations of any state or federal agency; or in violation of this Agreement; or in violation of municipal, state, federal or international law.

### VII. INDEMNIFICATION

CUSTOMER AGREES TO INDEMNIFY AND HOLD PROVIDER, ITS GOVERNING BOARD MEMBERS, OFFICERS, MEMBERS, EMPLOYEES AND/OR AGENTS HARMLESS FROM ANY CLAIMS, SUITS, LIABILITY, LOSS, EXPENSES AND/OR DAMAGES, INCLUDING ALLEGED COPYRIGHT AND OTHER INTELLECTUAL PROPERTY CLAIMS, SUSTAINED BY ANY PERSON BY REASON OF ANY ACT OF CUSTOMER OR ITS USERS IN THEIR ACTIVITIES INVOLVING USE OF PROVIDER'S NETWORK.

### VIII. TITLE AND OWNERSHIP

- A. Title to the Service Equipment shall irrevocably and under all circumstances remain with the Provider and its designees, and the Customer will take no action to knowingly compromise the rights, title, and interest of the Provider. The Customer's interest in the Services and Service Equipment is limited to non-exclusive use thereof on the Customer's premises.
- B. All written procedures and similar items utilized or developed in connection with this Agreement, residing with Providers, are not to be considered the property of Customer.

### IX. CONFIDENTIALITY OF INFORMATION

- A. Provider shall exercise reasonable ordinary care in preserving and protecting the confidentiality of information furnished by Customer.



#### Significant Variances:

*Receipts* - The Property Taxes category currently reflects the County's full 2020 2nd half settlement coupled with the County's full 2021 1st half settlement. The slight increase in assessed valuations of approx. 0.6% between tax year 2021 and 2020 is contributing to the increase coupled with a one time payment of prior tax years from the MGM tax valuation settlement. The Tangible Personal Property Tax assessed valuations increased by 7.88% between tax year 2021 and 2020. This increase in valuations is the main contributor of the 6.8% increase in this revenue type when compared to the prior year. The increase in the Restricted State Grants-in-Aid category is due to the new School Funding Model which has now been implemented at the State level. Restricted State funds in the form of Student Wellness and Gifted Education are now funded separately within the General Fund. These new funding sources are driving the increase in Restricted State funds for the current year. The All Other Revenues category is showing a significant increase which is mainly contributed to: 1) Kindergarten tuition collected through May 2022 compared to the collections through May 2021 (COVID) is up 61.36% and 2) Additional tax settlements (specifically MGM) received through May 2022 compared to prior year to date are up 255.16%. Finally, the Other Financing Sources category is showing a decrease due to a large BWC refund received in FY 20-21 while the BWC refund received to date for FY 21-22 is considerably smaller.

*Expenditures* - Salaries and wages are higher when compared to the same time last year due to a negotiated wage increase of 3% across all classifications of District employees for the 2021-22 contract year coupled with the impact of step adjustments and educational movements done throughout the fiscal year. The year-to-date variance in Employee benefits through May 2022 when compared to May 2021 was 0.7% higher than the prior year-to-date amount. The District took two premium holidays in fiscal year 2021-22 (July and August) which is the same amount taken in fiscal year 2020-21 (August and September). The movement of certain staff to ESSER funding for this current school year has helped control general operating costs in the Salaries/Wages and Employee Benefits line items. The Supplies and Materials category is reflecting a 22.4% increase due to classroom supplies and building supplies needs compared to last year when the need for such supplies was minimized due to the school closures and hybrid learning models. Additionally, fuel remains higher by 119.04% due to increased fuel prices as well as increased transportation services for FY 21-22. The Capital Outlay line is currently 7.1% higher this year when compared to the prior year's amount due to the District's investment in updating the interactive touch panels throughout all K-8 classrooms.

#### SETTLEMENT AGREEMENT

This Settlement Agreement (the "Agreement") is made and entered into this \_\_\_\_\_ day of July, 2019, by and between DOTRS Limited Liability Company ("DOTRS") and the Nordonia Hills City School District Board of Education (the "District") for the sole consideration set forth herein.

WHEREAS, DOTRS and the District have each reviewed information concerning the Property and retained separate real estate appraisers and/or consultants, and desire to agree to establish the value of the Property for tax years 2018, 2019, 2020, 2021 and 2022, subject to the following provisions; and

WHEREAS, DOTRS and the District, having taken into account (1) the potential for increase in real estate taxes upon the Property for tax years 2018, 2019, 2020, 2021 and 2022 that could arise from the prosecution of the Complaint or a future Complaint Against the Valuation of Real Property that may be timely filed against the Property (the "Future Complaint"), (2) the additional legal and appraisal costs each party would respectively bear in the Complaint or the Future Complaint, (3) the risk of an adverse determination of each party's respective position in the Complaint or the Future Complaint, (4) the respective adverse effects the delay of the resolution of this dispute would have upon the parties, and (5) the net advantage to each of the respective parties, the District's students, DOTRS, and the Property's tenants of the resolution embodied herein, wish to fully resolve and dispose of any and all matters and issues between them relating to the valuation of the Property for tax years 2018, 2019, 2020, 2021 and 2022 through this Agreement.

NOW THEREFORE, for the valuable consideration set forth herein, the sufficiency of which is hereby acknowledged, the parties agree as follows:

1. DOTRS shall make additional real estate tax payments directly to the District in the following amounts and pursuant to the following payment schedule:

- A. A check in the amount of Two Hundred Eleven Thousand, Five Hundred Fifty Two Dollars (\$211,552.00) made payable to the "Nordonia Hills City School District Board of Education" and delivered to counsel for the District by August 15, 2019; and
- B. A check made payable to the "Nordonia Hills City School District Board of Education" and delivered to counsel for the District by February 28, 2020 in an amount to be determined by applying the following formula: \$38,500,000 less the Fiscal Officer's aggregate fair market value for the Property for tax year 2019 times 35% times the District's effective tax rate for commercial property as established by the Ohio Tax Commissioner and published by the Fiscal Officer for tax year 2019. Counsel for the District shall calculate the amount due the District to satisfy DOTRS's payment obligation under this Paragraph by using the formula set forth above, and shall notify counsel for DOTRS's payment obligations required by this Paragraph.
- 2. In consideration for DOTRS's satisfaction of its payment obligation specified in Paragraph 1.A above, the District shall withdraw the Complaint. In consideration for DOTRS's satisfaction of its payment obligation specified in Paragraph 1.B above, the District shall forbear from filing a Future Complaint against the Property for tax year 2019.
- 3. In the event that the Fiscal Officer values the Property at an aggregate fair market value below \$38,500,000 for tax year 2020, 2021 or 2022, DOTRS agrees to make additional real estate tax payments directly to the District in the following amounts and pursuant to the following payment schedule:
  - A. A check made payable to the "Nordonia Hills City School District Board of Education" and delivered to counsel for the District by February 28, 2021 in an amount to be determined by applying the following formula: \$38,500,000 less the Fiscal Officer's aggregate fair market value for the Property for tax year 2020 times 35% times the District's effective tax rate for commercial property as established by the Ohio Tax Commissioner and published by the Fiscal Officer for tax year 2020.

B. A check made payable to the "Nordonia Hills City School District Board of Education" and delivered to counsel for the District by February 28, 2022 in an amount to be determined by applying the following formula: \$38,500,000 less the Fiscal Officer's aggregate fair market value for the Property for tax year 2021 times 35% times the District's effective tax rate for commercial property as established by the Ohio Tax Commissioner and published by the Fiscal Officer for tax year 2021.

A check made payable to the "Nordonia Hills City School District Board of Education" and delivered to counsel for the District by February 28, 2023 in an amount to be determined by applying the following formula: \$38,500,000 less the Fiscal Officer's aggregate fair market value for the Property for tax year 2022 times 35% times the District's effective tax rate for commercial property as established by the Ohio Tax Commissioner and published by the Fiscal Officer for tax year 2022.

Counsel for the District shall calculate the amount due the District to satisfy DOTRS's payment obligations under this Paragraph by using the formula set forth above, and shall notify counsel for DOTRS no later than January 31, 2021, January 31, 2022 and January 31, 2023, respectively, of the exact amount needed to satisfy DOTRS's payment obligations required by this Paragraph. In consideration for DOTRS's satisfaction of its payment obligation specified in Paragraph 3.A, 3.B and 3.C above, the District shall forbear from filing a Future Complaint against the Property for tax year 2020, 2021 and/or 2022.

- 4. In the event that the Fiscal Officer values the Property at an aggregate fair market value above \$38,500,000 for tax year 2020, 2021 or 2022, the District and DOTRS agree to stipulate before the BOR to a \$38,500,000 aggregate fair market value for the Property for either tax year 2020, 2021 and/or 2022.
- 5. Notwithstanding anything in the Agreement to the contrary, DOTRS and the District agree that the provisions of Paragraph 1.B, Paragraph 3, and Paragraph 4 above shall not apply to any tax year covered by the Agreement for which a Future Complaint may be timely filed in response to an arm's length sale of the Property, or any portion thereof.
- 6. DOTRS and the District acknowledge that the amounts set forth in Paragraphs 1 and 3 above constitute additional real estate payments for tax years 2018 and 2019 and, if applicable, tax years 2020, 2021 and 2022, that shall apply and be allocable based upon the schedule set forth on Exhibit B, which is attached hereto and incorporated herein by reference.

- 7. The parties hereto acknowledge that DOTRS was not delinquent in any payment of taxes and acknowledge that this Agreement in no way alters DOTRS's obligations to pay real estate taxes properly assessed and billed against the Property by the appropriate governmental authorities.
- 8. The WHEREAS clauses are hereby incorporated into the Agreement by reference.
- 9. This Agreement sets forth the entire Agreement between the parties and fully supersedes any and all other prior agreements or understandings between the parties pertaining to the subject matter hereof. No provision of this Agreement may be modified, waived, or discharged unless the waiver, modification or discharge is agreed to in writing and signed by the parties. No agreements, or representations, oral or otherwise, express or implied, with respect to the subject matter hereof, have been made by either party that are not set forth expressly in this Agreement.
- 10. The parties agree they have read this Agreement, have retained legal counsel, understand its terms and voluntarily accept the consideration recited above for the purpose of making a full and complete compromise, adjustment and settlement of any and all claims.
- 11. The parties represent that the persons signing the Agreement on behalf of DOTRS and the District do so with the authority to bind DOTRS and the District, respectively, to all the terms of the Agreement, and that all necessary action has been taken by both parties to empower DOTRS and the District, through their authorized representatives, to execute and deliver the Agreement and all other documents required to implement same.


